

NOTICE TO TAXPAYER

2015 UNITY TOWNSHIP REAL ESTATE ASSESSMENT PUBLICATION LIST

The following is a listing of all taxable property in WILLOW BRANCH township. The 3 year average median level of assessments based on non farm property compared to the prior years assessed value for the years 2012, 2013 and 2014 was 33.33%. A 1.000 factor will be applied to all non farm land and buildings. You may check the accuracy of your assessment by multiplying it by 3. If the resulting value is greater than the 2015 estimated fair cash value of your property, you may be overassessed. Pursuant to 35 ILCS 200/10-115, the farmland assessments for the 2015 assessment year will increase by 10% of the preceding year's median cropped soil productivity index reduced by \$5.00 per acre as certified by the Illinois Department of Revenue with data provided by the Farmland Assessment Technical Advisory Board resulting in \$15.33 per acre increase for each soil productivity index. Property owners in WILLOW BRANCH township may file an appeal on their assessment to the Piatt County Board of Review by filing a written complaint in the Supervisor of Assessments office within 30 days of the date of this publication.
