The County Board of Piatt County convened in Courtroom 1 in the Courthouse and by ZOOM audio conference in the City of Monticello, County of Piatt and State of Illinois on Thursday, the 12th day of November, A.D. 2020, at the hour of 9 o'clock in the morning and was called to order by Chairman Ray Spencer.

On roll call the following Board Members and County Officers responded: County Board Members, Shannon Carroll, Renee Fruendt, Dale Lattz (via ZOOM), Robert Murrell, Randy Shumard, and Ray Spencer; Sheriff David Hunt, State's Attorney Dana Rhoades, and County Clerk Jennifer Harper. On proclamation by Chairman Spencer, the Honorable County Board was declared to be in session pursuant to adjournment.
