# Piatt County Coroner's Office Chief Deputy Coroner- Job Description

# **Job Summary:**

Assists the coroner in the planning and direction of the department operations which includes the investigation of deaths within the geographic boundaries of Piatt County. This position will be responsible for covering call at least 2 shifts per month and will provide administrative coverage while the coroner is out of town or otherwise not available.

Provides administrative coverage in areas such as budget planning, administration and hiring of personnel and assists the coroner in developing and administering standards, policies and procedures.

The Physical Demands of the position while performing the duties of the job consist of frequent standing, sitting, walking, talking and hearing. You may have to occasionally reach with your hands/arms, stoop, kneel, crouch or crawl. You may occasionally have to lift upwards of 300 pounds.

The Work environment while performing job duties frequently exposed to hot/cold, dry/wet environments and scenes. You may also be exposed to toxic chemicals, caustic chemicals, bio-hazard material, moving equipment, and other precarious places.

The chief deputy shall be a conservator of peace within Piatt County and provide support for families, law enforcement, funeral homes, tissue and organ banks, insurance and attorney requests and other inquiries as received by the office. and, in the performance of his duties as such, shall have the same powers as the sheriff.

The chief deputy shall remain free from any conflicts of interest pertaining to fire, law enforcement, or medical facilities within Piatt County. And in the same must abide by all confidentiality standards as well as HIPAA Standards.

## **Supervises:**

Directs deputy coroners to maintain the standards of the office and handles personnel issues and then reports finding to the coroner for final determination of resolution. Interviews and trains new hires, directing work and appraising performance, rewarding and discipline and addressing complaints. Conducts yearly performance reviews of deputy coroners.

### **Inter-Relationships:** Works closely with:

- 2. Area Law Enforcement during aspects of death investigations
- 3. State's Attorney during certain death investigations
- 4. Area Fire and EMS Agencies during aspects of death investigations

- 6. Family Members of the decedent during notification and follow-up contacts
- 7. Hospice and Home Health care personnel
- 8. Out of County Coroners in coordination of death investigations and death notifications

- 9. tissue, organ and anatomical gift programs
- 10. Illinois Department of Public Health and the IDPH IVRS Database for creation of death certificates/cremation permits

**Essential Functions:** Honesty, Integrity, Accuracy, Efficiency, Care, Concern, and Compassion in all areas of duties and responsibilities

**Duties and Responsibilities:** (Listed in Random Order, not in order of Priority)

- 1. Respond to death scenes, take charge of the body, and make preliminary investigation into circumstances of death and be willing to work in any environmental condition, as well as be physically fit to stand or sit for long periods of time
- 2. Attempt to ascertain the cause of death, either by autopsy or by obtaining statements and information from family or witnesses
- 3. Take charge of valuable property, money, papers, and deliver to next of kin after property has been cataloged/inventoried
- 4. Complete all paperwork and mandated by law or Coroner's office policy
- 5. Be a conservator of peace in Piatt County
- 6. Perform any duties of the coroner in the name of the coroner, during absence
- 7. Make positive identification of the body by whatever means is possible
- 8. Report all suspected SIDS deaths to the Statewide Program within 72 hours
- 9. Issue permits to cremate to funeral directors as requested
- 10. Issue death certificates using IVRS database system from IDPH
- 11. Respond to telephone requests from families, medical personnel, funeral homes, hospice/home health, news media, county officials, law enforcement, attorneys, insurance agents, and the public as needed
- 12. Work closely with the coroner in making the Piatt County Coroner's Office a Professional office within the county, maintain good public relations both on and off duty
- 13. Collect medications and catalog all medications using appropriate form follow standard in policy manual for storage
- 14. Good computer skills using multiple databases and software programs
- 15. Abide by the Policies of the Office and have a good working knowledge of the policies
- 16. Report Child/Elder abuse as required by law to the appropriate authority
- 17. Testify in court or at other legal proceedings, when subpoenaed to do so or at the request of the States Attorney
- 18. Participate in mandated or voluntary training classes, conferences, programs
- 19. Make death notification, in person, if possible, to next of kin
- 20. Complete all follow-ups with next of kin regarding cause of death, impending proceedings, and other requests
- 21. Participate in community programs, public relation programs, and public speaking engagements
- 22. Possess a valid Illinois Driver's License and have a legally insured, operable and dependable vehicle

23. Possess a thorough knowledge of Piatt County, locations of cities and villages and road coordinates either by map reading or GPS, 911 Maps will be provided to all deputies and will be updated every few years
